NOTES FROM THE PRESIDENT

I regret that I must begin this Newsletter with complaints but many homeowners have complained about the children and their behavior while utilizing the community lot. Several complaints involve children climbing on trees, breaking or cutting down trees in the community lot, pulling up "No Parking" signs, digging holes to build skate board ramps, and the use of pellet guns.

Surrounding homeowners have complained of property damage from the children and the use of branches and trees being thrown into their yards, their animals are being taunted, and their landscaping damaged.

Some of the most concerning incidents have been children crawling in a storm drain and other children closing the top of the drain, with children still inside!!!!! Another person witnessed a child climbing on the electrical box in the community lot, then climbing the fence into the adjoining neighbor's yard and that yard has a pool.

Due to these complaints, and our concern for children's safety, the Board of Directors has approved the installation of signs listing rules and regulations for use of the community lot. We hope to have these installed in the next few weeks. They will be posted under the "No Parking" signs and near the wooded area of the community lot. In this newsletter, you will find the list of the rules and regulations. We ask that parents review these with their children so they become familiar with them. We also have asked for parents to be with their children while on the community lot if the child is under 10 years old.

We also will be marking the lot lines with a sign indicating where the community lot ends and other homeowners' lots begin, so it is easily identified for the children as they play on the lot.

Your cooperation will be appreciated.

YARD OF THE MONTH



HAPPY SPRING!

Spring is here with temperatures that have allowed us to venture outside again. Many of you have taken advantage of this weather to concentrate on your lawns. I would like to let everyone know that as of this month, they are all now "in the running" for YARD OF THE MONTH!

Does your yard need to be immaculate to win? **NO**, but it does need to adhere to some basic criteria to "make it" as a LPE YOTM. I will be looking for clean line, consistency in the up-keep, and uniformity in its elements. Here are a few guidelines that will help you better understand the judging this year, though much of them are the same as last year.

• No bare patches visible from the road;

- Clean edges on lawn and natural areas;
- No weeds in the natural areas;
- Matching mulch throughout;
- Mowed lawn;
- If you choose to prune your shrubs, they do not have to be perfectly rounded or squared. Just no "fly away" shoots jutting out;
- Like it or not, mailboxes factor into the overall appearance of your lawn. Make sure that they are painted, rust-free, have no rotted wood and are to code;
- House numbers should be complete and visible;
- Be consistent. I will view lawns throughout the month and consider the one that reflects the owner's efforts ALL MONTH LONG; and
- Be up-to-date on your homeowner association dues!

Remember that the Yard of the Month gets a special recognition sign for a month, as well as a \$25 Lowe's Gift Card. Yards will be judged starting in April through to September with special recognition on Halloween and Christmas. I will email out to those that express an interest and send me their email addresses, each month's winner as well as the following 4 that were under consideration. That way you can see if your yard was in the top 5, and if you may need to take that extra step to "make it happen" in the following months!

I welcome any and all input from my neighbors. We should all take part in recognizing those in our community that help to set the standard! So please, email me your nominations for one or more yards that you feel warrant YOTM "status." Be sure to place "YOTM" in the subject line, so that your email doesn't get spammed or overlooked though I will take all nominations into consideration and really appreciate any time that you contribute in helping to make those hard choices just a little easier!

TRAFFIC CIRCLE UPDATE

The traffic circle construction at the entrance of the development is approaching quickly!!!! This is the latest update from SCDOT. Bids for construction are in May, 2010, the bid is awarded to the contractor in June, 2010, and construction is set to begin in June, 2010. As you will recall from the general meeting, hours of construction will be Monday-Friday 9AM to 4 PM, Saturday and Sunday 9PM to 6 AM. Remember

these dates and times are tentative and still are subject to change.

During construction, slow down signs will be posted. You may have noticed the entrance has stakes where the construction will take place. Please check the website for further updates. This is where the board will post information as we receive it.

CRIME WATCH UPDATE

As part of our last HOA meeting we were fortunate enough to have representatives from the Lexington County Sheriff's Office (LCSO) provide a presentation on the establishment of a neighborhood crime watch. Although the turnout could have been much better there have been significant strides in the development of a crime watch program that will allow for the timely exchange of crime related information, e.g. break-ins, vandalism, "suspicious activity", etc. This exchange of information can most effectively be obtained via the use of Internet email communication whereby participants will send an email to the crime watch program. The information will then be promptly distributed to all participants and logged/categorized for submission to the LCSO. As our program matures and consistent participation is established our interactions with the LCSO should provide additional benefit in obtaining other crime related information in and around our area of Lexington.

However, in order to make this happen we will need your help. We need all neighborhood homeowners to participate in this email notification system for this to work. We have had great success in obtaining the email participation from the people who have been asked via the door-to-door method, but this is slow

going. It would be of great benefit for anyone/everyone who is not already participating to send me an email at mhb1234@windstream.net stating that you would like to participate in the crime watch program and I will send further details. I look forward to hearing from all of you. Thanks,

I am sure that you are all aware of the pending school budget cuts, as well as, our struggling economy. What better time to get involved with our local schools and help out in whatever capacity possible...big or small.

With that said, this is what I am asking...if you happen to have small toys (new or used) i.e....happy meal toys, stickers, play jewelry, pencils, cards, yo-yos, small pic frames, books, etc...anything left-over at the end of garage sale day or even if you are not participating but have these items that you would like to get rid of, instead of tossing them in the trash or taking them to the Thrift store, would you consider donating them to our schools? These types of items are given out to students at all levels as rewards for

good behavior or a job "well done". Students at both schools look forward to this type of positive reward system.

The CSE PTO and school have also implemented quite a few recycling programs over the past few years that we use to help raise money as well as educate our students on the importance of recycling. We would be delighted if any members of our community would like to help us in this venture by donating or volunteering their time!! We recycle the following items for cash:

- Drink Pouches- please, pull out the straw, cut a slit in the bottom "pouch", rinse off and dry before placing in a Ziploc baggie. This is a VERY time-consuming project, but one that we feel is well worth the effort to educate our students on the benefits of recycling. They love to feel a part of it by recycling these during lunchtime!! To date, CSE has recycled OVER 6,000 pouches!
- Elmer's Glue Sticks and Bottles-Rinse well, dry and place in a baggie.
- Frito-Lay Bags Just empty these and lay flat....ANY SIZE!
- ➤ <u>Huggies Diaper Wrappers</u> -Try to tear open only the tops ;)
- **Cell Phones**-When getting a new one; give us your old one.
- Printer Cartridges-Send us your old ones and see if your office or place of work would be willing to donate theirs.
- ➤ Writing Utensils -Instead of throwing out those useless ballpoint pens, send them to us, and we will recycle them!
- ➤ Both schools collect **General Mills Box Tops** throughout the year!

RULES AND REGULATIONS FOR USE OF THE COMMUNITY LOT

- 1. Usage time: 10AM-8PM (9PM in the summer months (April-September)
- 2. Children 10 years or younger will need to have parental supervision to be on the lot.
 - 3. No smoking or alcoholic beverages allowed on the lot.
 - 4. No firearms or weapons allowed on the lot. Examples of these are knives, pellet guns, rifles or other guns. No fireworks allowed.
 - 5. No matches or lighters allowed.
- 6. Climbing of trees, structures, or entry into storm drains in the community lot is strictly prohibited.
 - 7. No cutting down of trees or branches located in the community lot will be allowed.
 - 8. Parents will be held responsible that their children or friends who may accompany their children abide by these rules. Parents will be held financially responsible for any damage to the community lot caused by their children.
