# TREASURER'S REPORT

Well the year is winding down and like many of you, I'm looking forward to the holidays. I would like to thank those of you that volunteered your time and efforts this past year. Currently, only 6% have not paid their dues. This number is down from last year, which is good for the entire neighborhood. Unfortunately, a lien will be placed on those that did not pay their dues.

Some of you may have seen some yellow signs posted at the front entrance and community lot. The county had posted the property due to failure to pay the taxes. We immediately contacted Lexington County to see what had gone wrong. The county had sent our tax bills to the wrong address. We were able to get the taxes paid and the address corrected.

We hired a management company in March and they have been very helpful in many ways. The management company reviewed our insurance and recommended that we include a Directors and Officers policy to protect the Board members, as a whole, from any legal actions. The Board voted to add this policy, so our policy premium did increase more than originally budgeted.

Another advantage of working with the management company is that the next year's budget has to be completed by the end of October. With their help, we have a budget that the Board voted to approve. This budget will be available at the December meeting. You will see some improvements in the proposed budget as the categories are shown in more detail.

Financially we've had a good year. We cut back on several items this year such as the amounts given to the yard of the month winners, the amount of pine straw put out, and used William Douglas to print and mail the newsletters.

# TRAFFIC CIRCLE COMING SOON

As you all are aware, there has been much debate and discussion to improve the traffic flow at Longs Pond and Nazareth Roads. This is an area of concern for our development due to the fact that it will greatly affect our entrance.

The Department of Transportation (DOT) has decided to develop a traffic circle to assist with the improvement of the traffic flow. According to research, a traffic circle reduces accidents by as much as 70%.

With the development of the traffic circle, Longs Pond Road will shift toward the ball field and line up with our entrance. The project will make our entrance wider and traffic from our development will merge around the circle.

The project is tentatively scheduled to take place in the spring of 2010. At present, they are now in the phase of "right-away acquisition". This is where the DOT sends a representative to purchase land that is needed or ask permission for an easement for the needed property. Our board should be contacted by the end of the year regarding this. The project should be let (awarded thru a bid process) to a contractor in March, 2010 and construction should begin in May, 2010.

Please be aware these dates are tentative and could change. The board will keep the members of the HOA updated as more information becomes available.

#### NEIGHBORHOOD CONCERN



In the past we have spoken regarding pets, and in particular about pet owners' responsibilities to keep control of their pets. Dogs have been our main focus whether it has been addressing leash laws or pooper scooping issues. However, whatever pet we own, we all feel the same about our pets – they are part of our families.

A resident has complained about cats roaming the neighborhood. The cats are unwelcome in the yard and can be a nuisance. Because of this, several cats have been captured and turned over to animal control. No notice was put up about stray cats being captured or "found." As a result, we received the following letter from a concerned neighbor.

Personally, I have lost two cats in the past few months that were family pets. At first, after hearing the complaint, I was upset that this person had possibly turned my pets over to animal control. I have gone to the Ball Park Road office looking for my pets but they have not been there.

After thinking about it for a time, I realized that it is my fault that they are missing because neither of the cats had collars or microchips. But, have you ever tried to keep a collar on a cat? It is impossible and even unsafe. The way they get into everything it is a hazard to have a collar that is likely to get caught on something and possibly choke the cat.

In light of all of this, I have looked up the leash laws for cats. Regardless of collar or not, a cat should not be out of his owner's yard. If the animal is, the owner should have control over the cat and it should respond to his owner's commands.

The resident was within his rights to capture the animals and turn them in. However, would it have been so hard to post a notice about a found cat on the stop signs?

We welcome any concerns you might have as neighbors and will be happy to voice those concerns for you. We can't find solutions if we don't know the problems. So please let us know what is on your mind.

# CRIME WATCH

We are planning to have a representative from the Lexington County Sheriff's Department attend the December Home Owner's Association meeting to reinitiate the crime watch for Long's Pond. This meeting will include explaining the roles and responsibilities of a crime watch and its participants, electing a chairperson/block captains, requesting volunteer participation, and scheduling a follow-up meeting. As a precursor to the December meeting there will be volunteers making door-to-door stops to provide residents with information on the crime watch and asking for participation.

As indicated in the last newsletter, the Crime Watch section will contain an update on any incidents reported of suspicious activity/incidents. Since the last newsletter there have been several incidents. Multiple "eggings" have occurred on Knott's Haven Loop. On August 31st there was a suspicious car parked at the end of Knotts Haven Loop without their lights on (in the middle of the road). It was a white Chrysler sedan. They were facing the vacant house. When they saw a resident watching them, they sped off around the corner without their lights on. And there have been multiple automobile break-ins that involved the theft of items, including GPS units. These break-ins only involved vehicles with the doors left UNLOCKED! Greater detail will be provided in future incident updates as the volunteer base expands and a system and organized format for reporting is developed. # HALLOWEEN – SATURDAY, OCTOBER 31

Last year we hired two Lexington County Deputy Sheriff Officers to patrol and help control parking at the front entrance. Several commented that they thought it helped keep the amount of traffic down and we didn't have any problems with parking at the front entrance. Overall, it had a positive impact to the safety aspect for the neighborhood.

This year, we are fortunate to have two Deputies again and they will be in place from 6:00 pm to 9:00 pm. We will have one at the front entrance again and one patrolling. If you have any trouble or see anything suspicious, please let the deputies know.

Below are some Halloween Safety Tips that you may want to include.

#### SAFETY TIPS FOR CHILDREN

- The best costumes are light colored or bright and reflective. Keep costumes short to avoid tripping and falling. Minimize the risk of contact with candles or other ignition sources by avoiding baggy pants, loose frills, or billowing skirts.
- Give every child a flashlight with fresh batteries. Remind them of traffic safety rules, and that they should cross streets at corners and never cross between parked cars.
- Make sure that children know how to call 9-1-1 or their local emergency number if they experience an emergency.
- Teach children to STOP, DROP and ROLL should their clothing catch fire: STOP immediately, DROP to the ground and cover face, and ROLL over and over to extinguish the flames.

#### **SAFETY TIPS FOR ADULTS**

- Be extra careful when driving as excited children can forget safety rules when crossing the street.
- Appoint a designated driver if you attend adult Halloween parties.
- Accompany children when they go out trick-ortreating.

#### **SAFETY AT HOME**

- Consider using only battery-powered lanterns, flashing lights or chemical light sticks instead of candles in decorations.
- Small flashlight candles are the safest for use in jacko'-lanterns. If you must use a candle, try a tea light or votive candle in a non-combustible holder. Always keep candles, matches and lighters out of the reach of children. Place candlelit jack-o'-lanterns on sturdy tables, away from curtains and other flammable objects. Never leave them unattended.

Candlelit jack-o'-lanterns should be kept away from landings and doorsteps where costumes can brush against the flame.

• Indoor candlelit jack-o'-lanterns should be kept away from curtains, decorations and other furnishings that can be ignited.

- Ensure that electrical outlets are not overloaded with holiday lighting or special effects. Keep exit doors unblocked. Replace bulbs on outdoor lights. Check that the batteries in your smoke alarms work.
- Keep pets safe by ensuring they stay away from the door. Do not let them outside.

# **SOCCER MAKES THE NEWS**

On September 29<sup>th</sup>, WIS reported a story on the PAC Panthers. They interviewed Jennifer Aurednik the PAC Director, Vince Williams, Varsity Boys Coach, and players Matthew Aurednik, Trevor Berry, and Mark Thompson. They talked abut the different sports being offered to Home educated students – soccer, basketball & cross country and why we are doing it. See the WIS story below.

COLUMBIA, SC (WIS) - It's September and that means high school sports are well under way. But in South Carolina, a group of high school aged students aren't allowed to compete. That's why a Midlands mother put together a home school athletic club so kids can play competitively.

Fourteen-year-old Matthew Aurednik has played soccer his whole life, but once he became a freshman, his shot at playing competitive sports was blocked. "Home school students are not allowed to play high school athletics," said Matthew's mom Jennifer. "That's just what it is, they're not allowed to play."

Jennifer didn't want her son to have to sit on the sidelines because of a South Carolina law. So once the kids reach high school age, this is their only chance to play competitively. "There was no opportunity for him and so I wanted to create an opportunity to play high school athletics," said Jennifer.

What she created was the Providence Athletic Club just a few months ago. So far, about 70 kids are participating in JV and Varsity level cross country, basketball and Soccer.

So what is Jennifer's son looking forward to the most? "Beating my friends mostly," said Matthew.

Matthew's team, the Panthers, may not be able to compete for state titles, but Coach Vince Williams says the high school teams better watch out come spring. "We got some quality athletes and if the high school coaches knew what they were missing they'd be crying," said Vince. High schools have to agree to play the Panthers.
